**Ordinances & Resolutions STATEMENTS**

**1917-2015 - Authorizing the Acceptance for Land Donation**

This Ordinance is Authorizing the Acceptance of Land Donation for Lot 1 of Block 569 also known as Avenue E.

**1918-2015 – Amending Chapter 73, Personnel Policies**

This Ordinance amends Chapter 73, Personnel Policies of the Township Code to Include a Donated Leave Program.

**1919-2015 – Appropriating Unexpended Proceeds of the Sale of Previously Issued Bonds**

This Bond Ordinance is Appropriating Certain Unexpended Proceeds of the Sale of Previously Issued Bonds and Notes to Finance the Cost of Additional Capital Improvements and Taking Related Actions.

**242-15 – Encourages the Use of Reusable Cloth-Type Shopping Bags.**

This Resolution supports using reusable cloth-type shopping bags as opposed to single use plastic bags.
