**10A. Amend Ord 1775-08 Purchase Portions of Land on Galloway Rd**

This Ordinance amends the original appraisal of \$16,900 to \$19,000 for B-1171 L-30 for 10,951 Sq Ft of property for widening & reconstruction & has been reviewed by our Solicitor.

**10B. Establish Limits on Political Contributions**

This Ordinance establishes limits on Political Contributions made by individuals or business entities seeking business with the Township.

**11A. Refund Excess Funds in Special Police Detail Escrow Account**
