10B. Amend Chap 233 Land Mgmt

This Ordinance clarifies the definition section related to permitted uses & also makes a correction to Table I.

10C. Amend Stormwater Control Ord Chap 233 Land Mgmt

This Ordinance has been revised to address maint & repair issues raised by the NJ Pinelands Commission & were reviewed by the PB Solicitors, Twp Eng & the Dir of PWs.

11A. Authorize Emergency Appropriation in 2008 Temp Budget

This Resolution authorizes the emergency temporary budget increase, due to the delay in the adoption of the 08 Mun Budget.

11B. Place to Place Transfer of Plenary Retail Consumption Lic

This Resolution authorizes the place to place transfer and reduction of premises for Blue Marlin Sports Bar & Grille.

11C. Authorize Cancellation of Sewer User Charge/270 Todd Ave

This Resolution authorizes the cancellation in the amt of \$285 in the name of Serneabad, Solaiman, Anana & Jaidev & deems the account inactive.

11D. Support Grant Application for Safe Routes to School Program

This Resolution authorizes the Twp to obtain funds from the NJDOT.

11I. Charitable Roadway Solicitation Approval

This Resolution grants conditional approval for the Police Unity Tour to hold a "coin drop" at the intersection of Jimmie Leeds (CR633) & Pomona (CR575) roads & is approved fr the Atl Co Bd of Freeholders & supported by the GTPD.

11J. Expenditure of Funds for Litigation bet AC & Trump Org.
