This Ordinance amends Ord 1635-05 as required under the Stormwater Mgmt Regulations Program & is recommended by the Eng & PWs Dir.

This Ordinance Repeals Ord 1616 & 1622-05 as it pertains to the Sex Offender Residency Prohibition.

11A. Release Performance Guarantee Post Maint Guarantee/Clarion Inn
