10A. Amend Sanitary Sewer Ord Titled Sewer Chap 281

This Ordinance creates a new sect entitled Recapture to allow commercial developers to recapture sanitary sewer infrastructure improvement costs required by the Mun Util Div to promote future commercial development & is recommended by the Dir of PW, Eng & Twp Solicitor.

10B. Convey Deed of Right of Way to Atl Co for Jimmie Leeds Rd

This Ordinance authorizes the Twp to convey a deed of right of way for parcels located on JLR.

10C. Street Vacation/Universal Recovery & Lynette land

This Ordinance allows for the vacation of Baltic, Artic, Atl, Pacific Aves & 4 un-named streets located SE of Wrangleboro Rd.

11A. Approval for Charitable Roadway Solicitation/Pomona Vol FC

This Resolution approves a “coin drop” solicitation on Jimmie Leeds (CR633) & Pomona (CR 575) roads, has been approved by Atlantic Co & supported by GTPD.

11B. Extend 1st Option Yr of Contract for Fire Apparatus Maintenance
