**10A. Street Vacation/Delker Blvd & Arizona Ave**

This Ordinance vacates a portion of Delker Blvd & a portion of Arizona Ave, with conditions & no objections from the Twp Eng, PW's Dept & the PB.

**10B. Amend Admin Code Chap 189-3 Land Sale Req**
