

ORDINANCE # 1916-2015

ORDINANCE OF THE TOWNSHIP OF GALLOWAY TO AUTHORIZE THE EXPENDITURE NOT TO EXCEED \$150,000.00, WHICH COMES FROM AVAILABLE FUNDS IN THE SEWER CAPITAL IMPROVEMENT FUND

BE IT ORDAINED by the Township Council of the Township of Galloway, County of Atlantic, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

Section 1. There are funds available in the amount not to exceed \$150,000.00 in the Sewer Capital Fund.

Section 2. The Township had an emergent condition occur in which a sewer main needed repair on Pomona Road.

Section 3. The appropriate statutes of the State of New Jersey provide for the expenditure of capital funds for this purpose.

Section 4. A sum not to exceed \$150,000.00 is hereby appropriated for said purposes above, in compliance with the Local Public Contracts Law of the State of New Jersey.

Section 5. This Ordinance, irrespective of approval upon second reading, shall be subject to the approval of said purposes by appropriate State Agencies including, but not limited to, the Department of Community Affairs and shall be forwarded to said agencies for their respective approvals upon passage.

Section 6. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 7. This ordinance shall take effect upon final passage, approval and publication as provided by law.
