

**ORDINANCE # 1928-2015**

**ORDINANCE OF THE TOWNSHIP OF GALLOWAY AMENDING CHAPTER 319 OF THE CODE OF GALLOWAY TOWNSHIP – VEHICLES AND TRAFFIC - TO PROHIBIT LEFT TURNS FROM THE PROPOSED 6<sup>TH</sup> AVENUE PLAZA ONTO JIMMIE LEEDS ROAD**

**WHEREAS**, the Municipal Council of the Township of Galloway finds it necessary to control vehicular traffic entering Jimmie Leeds Road from the proposed Sixth Avenue Plaza in the Township of Galloway; and

**WHEREAS**, the proposed development was approved by the Planning Board via Decision and Resolution 4-15 on June 4, 2015; and

**WHEREAS**, the Atlantic County Department of Regional Planning and Development is requiring an Ordinance adopted by the Galloway Township Council prohibiting left turns out of the property onto Jimmie Leeds Road; and

**WHEREAS**, the property owners will prohibit left turns out of the property onto Jimmie Leeds Road, as there will be no turning restrictions for the Sixth Avenue entrance due to the full access traffic light at Jimmie Leeds Road and Sixth Avenue; and

**NOW THEREFORE, BE IT ORDAINED** by the Governing Body for the Township of Galloway, County of Atlantic and State of New Jersey, that Chapter 319, Vehicles and Traffic, section 40, is hereby amended to add the following property:

**Sixth Avenue Plaza  
Intersection of Sixth Avenue and Jimmie Leeds Road**

- I. **Parking** – All vehicles must be parked only in designated areas and between the lines provided.
- II. **Speed Limits** – The speed limits for both directions of traffic in the parking lot shall be fifteen (15) miles per hour.
- III. **Tow-Away** – Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills any grass area, pedestrian walkway, in front of dumpsters, or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner’s or operator’s expense.
- IV. **Parking Prohibited** – No person shall park a vehicle at any time upon the location or parts thereof described.

- V. **Turn Prohibitions** – Vehicles will be prohibited from making left turns when exiting the driveway on Jimmie Leeds Road.

**BE IT FURTHER ORDAINED**, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

**BE IT FURTHER ORDAINED**, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

**BE IT FURTHER ORDAINED**, that the Ordinance shall take effect following adoption and approval in the time and manner prescribed by law.

**NOTICE IS HEREBY GIVEN** that the foregoing Ordinance was introduced in and passed the first reading at a meeting of the Township Council of the Township of Galloway, County of Atlantic and State of New Jersey, held on November 10, 2015, and said Ordinance will be further considered for final passage and adoption at a public hearing to be held at the Municipal Complex located at 300 East Jimmie Leeds Road, Galloway, New Jersey 08205, on November 23, 2015, at 6:30 PM or as soon thereafter as the matter may be reached.
